Approval of Open Consent Agenda

RESOLVED THAT the consent agenda for the open session of the BCCNM Board meeting held on April 27, 2023 be approved:

- a) RESOLVED THAT the minutes for the open session of the BCCNM Board meeting held on January 26, 2023 be approved.
- b) **WHEREAS** the Midwifery Panel of the Professional Practice and Standards Committee (the "Committee") has reviewed the revision to *Table 1: Schedule A Medications Limits and Conditions* within the *Registered Midwives Medications and Substances: Standards, Limits and Conditions* to include vitamin and mineral supplements for the purpose of nutritional therapy and support with no additional limits and conditions, as set out in Appendix A of the Board Briefing Note dated April 13, 2023, and prepared for the April 27, 2023 BCCNM Board meeting (the "Briefing Note"), a copy of which

has been presented to the BCCNM Board, and the Committee has recommended those revisions to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered those proposed revisions and accepts the Committee's recommendation;

RESOLVED that the BCCNM Board approves the revised *Registered Midwives Medications and Substances: Standards, Limits and Conditions* set out in Appendix A of the Briefing Note;

FURTHER RESOLVED the *Registered Midwives Medications and Substances: Standards, Limits and Conditions*, as set out in Appendix A are in effect immediately upon approval by the BCCNM Board.

- the Novatone Report, which outlines the findings and recommendations arising from an external, independent review of BCCNM's complaints process using a cultural safety, cultural humility, and antiracism lens; and
- d) an overview of BCCNM's leadership model, which explains the college's approach to developing and growing its leaders, including the tools, skills, and resources as related to cultural safety and humility.

Proposed Bylaw Amendments: RN/RPN Certified Practice for Opioid Use Disorder

The Board considered bylaw revisions to enable certified practice for registered nurses and registered psychiatric nurses for the treatment of opioid use disorder.

RESOLVED THAT in accordance with the authority established in section 19(1) of the *Health Professions Act*, and subject to filing with the Minister of Health as required under section 19(3) of the *Health Professions Act*, the Board amends the bylaws of the British Columbia College of Nurses and Midwives, by repealing the current bylaws and substituting the attached new bylaws, a redline markup of the current bylaws showing the amendments (Appendix B).

Certified Practices Course Review – Revised Policies

Applying X-Rays Limits and Conditions – Nurse Practitioners

WHEREAS the Nurse Practitioner Panel of the Professional Practice & Standards Committee (the "Committee") has reviewed the revised *Nurse Practitioner Scope of Practice: Standards, Limits and Conditions: C: Ordering Diagnostic Services and Managing Results* limits and conditions and the *Nurse Practitioner Scope of Practice: Standards, Limits and Conditions: E: Advanced Procedures and Activities* limits and conditions, set out in Appendix A of the Board Briefing Note dated 18 April 2023 and prepared for the 27 April 2023 BCCNM Board meeting (the "Briefing Note"), a copy of which has been presented to the BCCNM Board, and the Committee has recommended those new limits and conditions to the BCCNM Board for approval,

AND WHEREAS the BCCNM Board has considered those revised limits and conditions and accepts the recommendation of the Committee;

RESOLVED that the BCCNM Board approves the revised *Nurse Practitioner Scope of Practice: Standards, Limits and Conditions: C: Ordering Diagnostic Services and Managing Results* limits and conditions, as set out in Appendix A of the Briefing Note;

FURTHER RESOLVED that the BCCNM Board rescinds limit 5(a) in the *Nurse Practitioner Scope of Practice:* Standards, Limits and Conditions: E: Advanced Procedures and Activities;

AND FURTHER RESOLVED that these standards are brought into effect immediately.

Revisions to Framework for Midwife Certification in Intrauterine Contraception Insertion

WHEREAS a Panel of the Education Program Review Committee, the Midwifery Panel of the Professional Practice and Standards Committee (the "Committees"), and Quality Assurance staff have reviewed the limits and conditions, certification and recertification requirements for the *Framework for Midwife Certification in Intrauterine Contraception Insertion*, as set out in Appendix C of the Board Briefing Note dated April 13, 2023 and prepared for the April 27, 2023 BCCNM Board meeting (the "Briefing Note"), a copy of which has been presented to the BCCNM Board,

AND WHEREAS the Committees and Quality Assurance staff recommend those revised limits and conditions, certification and recertification requirements to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered those proposed revised limits and conditions, certification and recertification requirements and accepts the Committees' and Quality Assurance staff recommendations;

RESOLVED that the BCCNM Board:

- 1) rescinds the delegation agreement between the College of Physician and Surgeons and the legacy College of Midwives of BC/BCCNM that allowed midwives to prescribe and insert intrauterine devices under delegation (Appendix B); and
- 2) rescinds the previously established Framework set out in Appendix A,

FURTHER RESOLVED that the BCCNM Board approves the limits and conditions, certification and recertification requirements in the *Framework for Midwife Certification in Intrauterine Contraception Insertion*, as set out in Appendix C of the Briefing Note;

AND FURTHER RESOLVED that the *Framework for Midwife Certification in Intrauterine Contraception Insertion,* as set out in Appendix C are in effect on May 18, 2023.
