2022 Financial Update and Proposed 2023 Budget and Fees

The Board recorded the decisions reached during its closed session on the 2023 budget and fees:

Funding Strategy

RESOLVED THAT the Board endorses the funding strategy depicted by Scenario 2 (15% increase).

AND RESOLVED THAT the Board approves the 2023-24 fees as presented in the new Schedule G at Appendix D (Scenario 2) of the report dated November 14, 2022, with an effective date of February 1, 2023.

AND WHEREAS the BCCNM Board has considered the revised *Medication* practice standard and accepts the Committee's recommendation;

RESOLVED THAT the BCCNM Board rescinds the previously established *Medication* practice standard for licensed practice nurses, nurse practitioners, registered nurses, and registered psychiatric nurses, and in its place approves the revised *Medication* practice standard for licensed practice nurses, nurse practitioners, registered nurses, and registered psychiatric nurses as set out in Appendix B of the Briefing Note;

FURTHER RESOLVED that the revised *Medication* practice standard as set out in Appendix B of the Briefing Note be in effect 30 days from approval by the BCCNM Board.

c) WHEREAS the Professional Practice and Standards Committee – LPN/RN/RPN Panel (the "Committee") has reviewed the proposed amendments to the licensed practical nurse scope of practice limit on participating in allergy challenge testing and desensitization treatment and proposed rescinding of licensed practical nurse and registered psychiatric nurse scope of practice limits and conditions on ankle brachial index testing and ear irrigation (syringing of ears) as set out in Appendices A, B, C, and D of the Board Briefing Note dated November 14, 2022 and prepared for the November 24, 2022, BCCNM Board meeting (the "Briefing Note"), a copy of which has been presented to the BCCNM Board, and the Committee has recommended those amended and rescinded scope of practice limits and conditions to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered proposed amendments to licensed practical nurse limits on participating in allergy challenge testing and desensitization treatment and the proposed rescinding of licensed practical nurse and registered psychiatric nurse limits and conditions on ankle brachial index testing and ear irrigation (syringing of ears) and accepts the recommendation of the Committee.

RESOLVED THAT the BCCNM Board rescinds all previously established *Licensed Practical Nurses Scope* of *Practice: Standards, Limits, Conditions* on allergy challenge testing and desensitization treatment, ankle brachial index testing and ear irrigation (syringing of ears) and approves in their place the amended *Licensed Practical Nurses Scope of Practice: Standards, Limits, Conditions* set out in Appendix B of the Briefing Note.

FURTHER RESOLVED that the Board rescinds all previously established *Registered Psychiatric Nurse Scope of Practice: Standards, Limits, Conditions* on ankle brachial index testing and ear irrigation (syringing of ears) and approves in their place the amended *Registered Psychiatric Nurse Scope of Practice: Standards, Limits, Conditions* set out in Appendix D of the Briefing Note.

FURTHER RESOLVED that the Licensed Practical Nurses Scope of Practice: Standards, Limits, Conditions set out in Appendix B of the Briefing Note and the Registered Psychiatric Nurse Scope of Practice: Standards, Limits, Conditions set out in Appendix D of the Briefing Note are in effect 30 days after approval by the BCCNM Board.

d) WHEREAS the LPN/RN/RPN panel of the Professional Practice and Standards Committee (the "Committee") has reviewed the proposed amendments to the education requirements for Remote Practice certification in Table 1 of the registered nurse scope of practice *Limits and Conditions for Certified Practice Registered Nurses* as set out in Appendix B of the BCCNM Board Briefing Note dated

November 14, 2022, and prepared for the November 24, 2022, BCCNM Board meeting (the "Briefing Note"), copies of which have been presented to the BCCNM Board, and the Committee has recommended those proposed amendments to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered and accepts the recommendations of the Committee;

RESOLVED THAT the BCCNM Board rescinds the previously established registered nurse scope of practice *Limits and Conditions for Certified Practice Registered Nurses* and in their place approves registered nurse scope of practice *Limits and Conditions for Certified Practice Registered Nurses* as set out in Appendix B of the Briefing Note;

AND FURTHER RESOLVED THAT these registered nurse scope of practice limits, and conditions are brought into effect 30 days from approval by the BCCNM Board.

Registered Midwives Medications and Substances: Standards, Limits, and Conditions

The Board reviewed a recommendation from the Professional Practice and Standards Committee to modernize and harmonize four midwifery practice standards.

WHEREAS the Midwifery Panel of the Professional Practice and Standards Committee (the "Committee") has reviewed the standards, limits and conditions for *Registered Midwives Medications* and Substances: Standards, Limits and Conditions, as set out in Appendix E, and the Registered Midwives Standards of Practice, Standard 15, as set out in Appendix G, of the Board Briefing Note dated November 14, 2022 and prepared for the November 24, 2022 BCCNM Board meeting (the "Briefing Note"), a copy of which has been presented to the BCCNM Board, and the Committee has recommended those revised and rescinded standards, limits and conditions to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered those proposed revised midwives medication and substances standards, limits and conditions and accepts the Committee's recommendation;

RESOLVED THAT the BCCNM Board rescinds the previously established midwife Standards set out in Appendix A, B, C, and D and in their place approves the standards, limits and conditions in the *Registered Midwives Medications and Substances: Standards, Limits and Conditions*, as set out in Appendix E of the Briefing Note;

FURTHER RESOLVED THAT the BCCNM Board rescinds the previously established *Registered Midwives Standards of Practice, Standard 15* as set out in Appendix F and approves the *Registered Midwives Standards of Practice, Standard 15*, as set out in Appendix G of the Briefing Note;

AND FURTHER RESOLVED THAT the *Registered Midwives Medications and Substances: Standards, Limits and Conditions*, as set out in Appendix E and the *Registered Midwives Standards of Practice, Standard 15* as set out in Appendix G are in effect 90 days after approval by the BCCNM board.
