RN and RPN Scope of Practice: RN Certified Practice Limits & Conditions and Update to RN/RPN Prescribing Standards Limits & Conditions

WHEREAS the LPN/RN/RPN panel of the Professional Practice and Standards Committee (the "Committee") has reviewed the proposed registered nurse scope of practice limits and conditions for certified practice and proposed amended registered nurse and registered psychiatric nurse scope of practice standards, limits and conditions when prescribing, as set out in Appendices B and D of the BCCNM Board Briefing Note dated September 20, 2022, and prepared for the September 29, 2022, BCCNM Board meeting (the "Briefing Note"), copies of which have been presented to the BCCNM

Board, and the Committee has recommended those proposed standards, limits and conditions to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered and accepts the recommendations of the Committee;

RESOLVED THAT the BCCNM Board approves the registered nurse scope of practice Limits and Conditions for Certified Practice Registered Nurses as set out in Appendix B of the Briefing Note;
