REx-PN Program Reports

With the recent launch of the REx-PN, NCSBN has let us know that Mountain Measurement will be offering REx-PN program reports for PN education programs in B.C. [Mountain Measurement](#) reports will be optional, detailed reports that programs can purchase. We previously sent an email indicating that Mountain Measurement would be offering a webinar on Feb. 3, 2022, but this

has been postponed. Mountain Measurement will be contacting all PN education programs about the rescheduled date.

BCCNM will be providing pass rates for the REx-PN to programs early in the following year. For the 2022 REx-PN pass rates these can be expected in early 2023. Please let us know if you have any questions by emailing exams@bccnm.ca.
