ON THE APPLICATION of the Respondent, College of Licensed Practical Nurses of British Columbia, coming on for hearing at 1355 Water Street, Kelowna, British Columbia on May 29 and 31, 2017, and on hearing Jason Herbert, counsel for the Respondent, and the Petitioner Brigitta Pelcz appearing on her own behalf;

THIS COURT ORDERS that:

- 1. The Petitioner is granted leave to amend her Petition to comply with the requirements of Form 66 under the Supreme Court Civil Rules (the "Rules"), and leave to file one or more affidavits in support of the Amended Petition, by June 28, 2017;
- Paragraphs 1 and 2 of the Respondent's Notice of Application filed on April 27, 2017 are adjourned generally, and may be reset by the Respondent any time after June 28, 2017;
- 3. The Petitioner's Notice of Hearing filed on April 12, 2017 is set aside, and the hearing of the Petition on its merits is adjourned generally;

- 4. The Petitioner must deliver to the Respondent and file with the Court, by June 28, 2017, her Amended Petition and any supporting affidavit(s) that comply with the *Rules*;
- 5. The Petitioner must not reset the Amended Petition down for a hearing without first consulting with counsel for the Respondent to identify a mutually agreeable date for the hearing;
- 6. The Respondent is entitled to its costs for the hearing of its Notice of Application on May 29 and 31, 2017 as costs in the cause; and
- 7. The requirement for the Petitioner to approve the form of this Order is hereby dispensed with.
