**AND WHEREAS** the Board has considered, and accepts, the Panel’s recommendation,

**RESOLVED THAT** in accordance with the authority established in section 19(1) of the Health Professions Act (the “Act”), and subject to filing with the minister as required by section 19(3) of the Act, the Board amends the bylaws of the British Columbia College of Nurses and Midwives, by repealing Schedule F and substituting the attached new Schedule F.
